Order

Sri V. Sambaiah has filed second appeal dated **30-08-2021** which was received by this Commission on **02-09-2021** for not getting the information sought by him from the Public Information Officer/ The Assistant Director, O/o the Mines & Geology, Warangal Rural District and the First Appellate Authority/ O/o the Mines & Geology, Warangal Rural District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **12-02-2021** before the Public Information Officer/ Tahsildar, Shayampet Mandal, Warangal Rural District requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- (1) స్టేట్ డ్రాఫ్ట్ డివిజన్ ప్లాంట్ల వివరాలు తెలియజేయమని విచారణ చేయమ.
- (2) డి.ఎస్.జి.ఎస్. పంక్షన్ పత్రాల ద్వారా స్టేట్ డ్రాఫ్ట్, డి.ఎస్.జి.ఎస్. వివరాలు తెలియజేయమని విచారణ చేయమ.
- (3) స్టేట్ డ్రాఫ్ట్, డి.ఎస్.జి.ఎస్. ప్లాంట్ల మీద చేసిన అన్ని అనుమతులు వివరాలు ఏ ఏ డ్రాఫ్ట్ల ఏ ఏ ప్రాజెక్టుల అనుమతులు తెలియజేయమని విచారణ చేయమ.
- (4) స్టేట్ డ్రాఫ్ట్, డి.ఎస్.జి.ఎస్. ప్లాంట్ల మీద చేసిన అనుమతులు (2015-2016) వరకు తెలియజేయమని విచారణ చేయమ.
- (5) 12/2/2021 తేదీన చేసిన అనుమతుల వివరాలు తెలియజేయమని విచారణ చేయమ.

The Public Information Officer through letter dated 23-02-2021 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ O/o the Mines & Geology, Warangal Rural District to take necessary action.

The Public Information Officer through Letter dated 30-03-2021 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **16-04-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **04-01-2022 at 10.30 AM.**

The Case was heard on 04-01-2022. The appellant is present and through affidavit stated that the PIO has not furnished the information. The PIO/ Sri B.Ravinder, Assistant Director, Mines & Geology, Warangal Rural District is present and stated that vide letter Lr.No.86/RTI/2016, dated.30-03-2021 part information was furnished to the appellant. The PIO further submitted a copy of the information along with the copy of the postal receipt. The FAA/Sri P.Madhusudan Reddy, Deputy Director, Mines & Geology, Warangal Rural District is present and stated that they have not received the first appeal from the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that though the PIO has furnished part information to the appellant, for remaining information the PIO ought to have forwarded the 6(1) application to the concerned PIOs to furnish the remaining information but failed to do so. The Commission warns the PIO not to repeat the same in the future and furnish the information following the provisions of RTI Act.

Hence the Commission directs the PIO to furnish the information once again to the appellant and for remaining information transfer the 6(1) application to the concerned PIO within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
