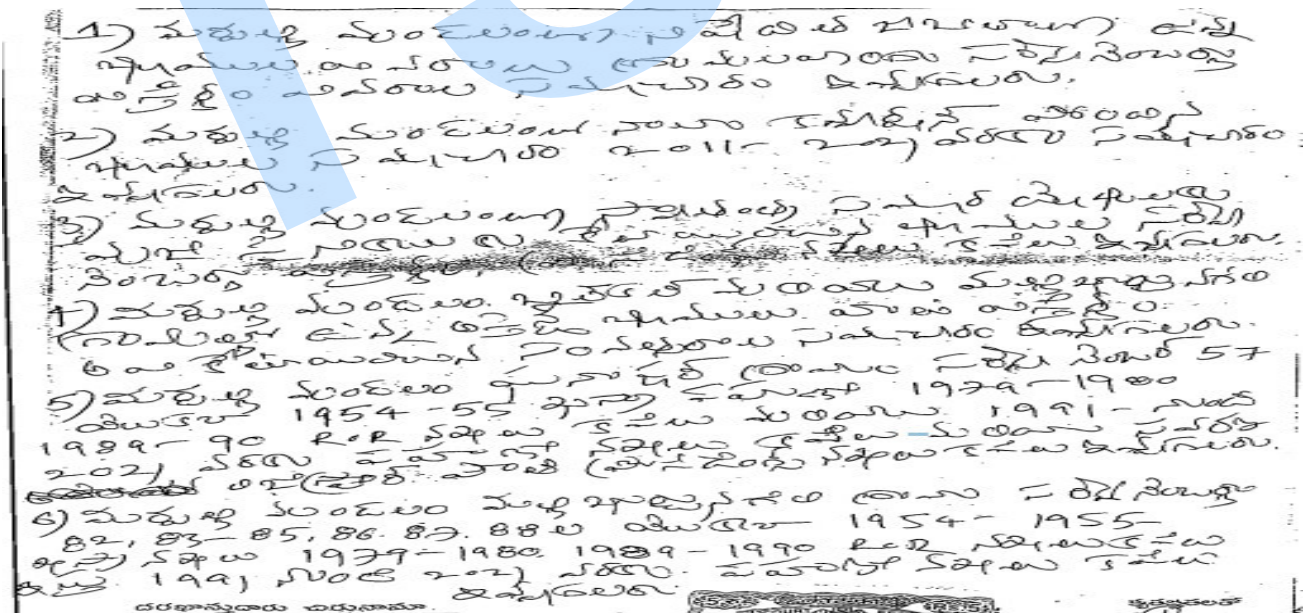

## Order

Sri M. Sreedhar has filed second appeal dated **28-08-2021** which was received by this Commission on **03-09-2021** for not getting the information sought by him from the Public Information Officer/ the Deputy Tahsildar, Marpalle Mandal, Vikarabad District and the First Appellate Authority/ the Revenue Divisional Officer, Vikarabad, Vikarabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **08-05-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:



### More (4) points.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **11-06-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **09-02-2022 at 10.30 AM.**

The Case is heard on 09-02-2022. The appellant is present and through affidavit stated that the PIO has furnished only part information on the day of hearing. The PIO/ Sri A.Venkata Chary, Deputy Tahsildar, Marpalle Mandal, Vikarabad District is present and filed his affidavit stating that the 6(1) application filed by the appellant is not received by their office, however the information sought by the appellant is furnished personally on the day of hearing. The PIO further submitted a copy of the information and stated that the information sought by the appellant for point No.2 of his 6(1) application is not specific hence the same was not provided to the appellant. Sri G.Amarendra Krishna, DAO, O/o. the Revenue Divisional Officer, Vikarabad Division is also present and stated that the appellant was absent for the hearing before the Appellate Authority.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the complainant except for point No.2 of his 6(1) application dated.08-05-2021 which is not specific.

Hence the Commission advises the appellant to seek specific information by filing a separate 6(1) application before the concerned PIO.

Since the information is furnished, the appeal is closed.
