Order

Sri R. Dharma Naik has filed second appeal dated **03-09-2021** which was received by this Commission on **04-09-2021** for not getting the information sought by him from the Public Information Officer/ O/o the DM&HO., Shivarampally, Rajendra Nagar, Ranga Reddy District and the First Appellate Authority/ O/o the DM&HO., Shivarampally, Rajendra Nagar, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **05-06-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. రంగారెడ్డి జిల్లాలో కృత్తిక ఆసుపత్రిలో కిరణ్ కుమార్
2. 2021 ఏప్రిల్ 1 నుండి ఈ రోజు వరకు ఆసుపత్రిలో వారి కృత్తిక ప్రియంట్ల కుమారుడు, ప్రియంట్ల వాణిని కుమారుడు, చివరిన బిల్లుల క్లియర్ అవుతుందని తెలుపగలడు.
3. వాణిని కుమారుడు కృత్తిక కుమారుడు తాళి కుమారుడు పుట్టిన తేదీలు తెలుపగలడు.
4. కృత్తిక - 19 వై ఇంటి వారు ఆసుపత్రిలో ఉన్న వారైనా తెలుపగలడు, వారికి ఆసుపత్రి కుమారుడు తెలుపగలడు.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **26-07-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-03-2022 at 10.30 AM.**

The Case is heard on 22-03-2022. The appellant is absent. The PIO/Sri P.Narahari, Administrative Officer(I/c.), O/o the DM & HO, Rangareddy District is present and stated that the appellant is seeking information for 4 points and vide letter Rc.No.2414/RTI/2021, dated.14-06-2021 the available information was furnished to the appellant and for point No.4 the appellant was informed that the same is under legal process. The PIO also filed a copy of the information along but failed to provide the copy of the postal acknowledgement.

Heard the PIO and perused the material papers available on record. The Commission observed that though the PIO has agreed that part information was furnished to the appellant but failed to provide the copy of the postal proof of dispatch.

Hence the Commission directs the PIO to furnish the part information once again to the appellant within one week through RPAD and after the completion of the legal process furnish the remaining information to the appellant and to report compliance to the Commission.

With the above direction, the appeal is closed.
