Order

Sri Mohd Abdul Gaffar has filed complaint dated **22-12-2020** which was received by this Commission on **23-12-2020** for not getting the information sought by him from the Public Information Officer/ The Revenue Divisional Officer, Malkajgiri, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **28-08-2020** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

This is to bring to your kind notice that SRI. Mohammed Abdul Gaffar S/O. Mohammed Abdul Sattar, R/o, H.No. 12,11-850/A, Ambernagar, Warasiguda, Sec,abad Hearing date : 02-12-2019 before the Appellate Authority and the Joint Collector at Keesara required to Notice for issue of Certified copies of File No. K/1742/2014 of Ravalkole Village, Medchal-Malkajgiri District. Need to issue vide A3/RTI, Appeal No. 29/2019 dt. 03-05-2019 Request to arrange my case certified copy. I will pay required fee for above transaction. Muntakab No.28 dt. 25-07-1968 G.O.Rt No. 1573 dt. 15-07-1978 for your kind information.

I have not affixed Rs.10/- Court fee stamp on the Application dated 29-07-2020, since I am affixing Rs.10/- Court fee on this Request letter.

I am requesting your good self to please consider this application and issue me File No. K/1742/2014 in respect of the above said land and do the needful most urgent.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **18-01-2022 at 10.30 AM.**

The Case was heard on 18-01-2022. The complainant is present and stated that he has not received the ORC sought by him through his 6(1) application. Sri S.Prabhudas, Naib Tahsildar on behalf of the PIO/Revenue Divisional Officer, Malkajgiri Division, Medchal Malkajgiri District is present and stated that vide letter Lr.No.K/RTI/258/2020, Dated.14-12-2020 the information sought was furnished personally to the complainant. The PIO further submitted the copy of the letter along with the personal endorsement of the complainant.

Heard both the parties and perused the material papers available on record. The Commission observed that the though the PIO has furnished the information to the complainant but the complainant claims that he has not ORC copy sought by him through his 6(1) application dated.14-09-2020.

Hence the Commission directs the PIO to once again call the appellant for verification of record as per section 2(j) of the Act by issuing prior intimation to the complainant and furnish the remaining information following the guidelines of Section 8, 9, 10 & 11 of RTI Act within one week through RPAD and to report compliance to the Commission.

With the above direction, the complaint is closed.
