Order

Sri G.K. Sampath Kumar has filed second appeal dated **22-12-2020** which was received by this Commission on **23-12-2020** for not getting the information sought by him from the Public Information Officer/ The DGM (Per), O/o the SCCL., Kothagudem Area, Bhadradri – Kothagudem District and the First Appellate Authority/ The GM (HRD), SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **28-09-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- to: K. S. V. -
- ① Please furnish number of years that Sri B. Rajgopal, Dy GM (Per) PM wing is working in Corporate PM wing.
 - ② Number of Individual Request transfers of NCCA employees initiated by Sri B. Rajgopal, Dy GM (Per) PM wing since he took joined in PM wing corporate furnish total number of transfers as on date.
 - ③ Number of Administrative Transfers proposals initiated by Sri B. Rajgopal, Dy GM (Per) PM wing for NCCA employees is as per the transfer policy point no: 28-3. Please furnish number of Administrative Transfers initiated by Sri B. Rajgopal, Dy GM (Per) PM wing as on date.
 - ④ Number of Request transfers proposals initiated by Sri B. Rajgopal, Dy GM (Per) PM wing is as per the transfer policy point no. 28-17 & as per his choice. Please furnish total number of request transfers proposals initiated by Sri B. Rajgopal, Dy GM (Per) PM wing after his posting to corporate PM wing to till date.
- number high court while giving and Supreme court

The Public Information Officer through Letter dated 03-10-2020 requested the concerned section in their office to provide the sought/ available information to the applicant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **28-10-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Letter dated 06-10-2020 requested the Public Information Officer to provide the sought/ available information to the applicant.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No. CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of "Singareni Formation Day Celebrations to be celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

In view of the above, informed to both the parties over phone to attend for hearing on **11-01-2022 at 10.30 AM.**

The Case is heard on 11-01-2022. The appellant is absent. The PIO/Sri Dhanpal Srinivas, DGM(P), SCCL, Kothagudem Area is present and submitted that vide letter Ref.No.CRP/RTI-PIO/3162/930, dated.27-10-2020 the appellant was informed that the since the information sought by him qualifies to be the personal and third party information and the same was rejected under Section 8(1) (j) of RTI Act, 2005.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has rejected to furnished the information to the appellant following Section 8(1)(j) of RTI Act, 2005.

The Commission did not accept the plea made by the PIO and directs the PIO to furnish the information to the appellant following the guidelines of Section 8, 9, 10 & 11 of RTI Act within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
