Order

Sri K. Kalappa has filed second appeal dated **08-09-2021** which was received by this Commission on **08-09-2021** for not getting the information sought by him from the Public Information Officer/ the Deputy Tahsildar, Mominpet Mandal, Vikarabad Division, Vikarabad District and the First Appellate Authority/ the Revenue Divisional Officer, Vikarabad, Vikarabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **29-05-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

కార్యాలయముకు సంబంధించిన U/3 ~~4(1)~~ 4(1)(B)
(1)(B) ప్రకారము 17 అంశములకు సంబంధించిన సమాచార
సాధన ఇవ్వగలరు.

The Public Information Officer through Memo No. A/16/2021 dated 07-2021 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **12-07-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Notice No. A/1186/2021 dated 07-2020 requested the appellant and the Public Information Officer to attend for hearing on 20-07-2021 at 11.00 AM along with necessary documents without fail.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **09-02-2022 at 10.30 AM.**

The Case is heard on 09-02-2022. The appellant is absent. The PIO/ Sri K.Ravinder Dutt, Deputy Tahsildar, Mominpet Mandal, Vikarabad District is present and stated that vide letter Lr.No.A/16/2021, dated.28-07-2021 part information was furnished to the appellant through registered post. The PIO further requested the Commission to provide them two days to furnish the remaining information to the appellant. Sri G.Amarendra Krishna, DAO, O/o. the Revenue Divisional Officer, Vikarabad Division is present and stated that the PIO/ Nayab Tahsildar, Mominpet Mandal, Vikarabad District was directed to furnish the information directly to the appellant.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished only part information to the appellant. The Commission took a serious view against Public Information Officer for not furnishing the complete information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Hence the Commission directs the PIO to furnish the remaining information to the appellant within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
