Order

Sri K. Kalappa has filed second appeal dated **08-09-2021** which was received by this Commission on **08-09-2021** for not getting the information sought by him from the Public Information Officer/ O/o the CHC., Marpalle Mandal, Vikarabad District and the First Appellate Authority/ O/o the CHC., Vikarabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **26-03-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1) 4/1/2017 లో బస్ క. పవిత్ర ల/ చంద్రశేఖర్ గారి పరుల్ మి hospital నుండి మెడికల్ రిపోర్ట్ బరి చేసినట్లు కల్పిడి అందులో చాక్కి గాయం అయినట్లుగా వీటూ వచ్చినట్లు X-Ray ఆసిస్ట్ గాం కల్పిడి ఈ రిపోర్ట్ మి Hospital నుండి బరి అయింద తెలివ తెలుపు నాను బరి పరిచా రిపోర్ట్ పై దృవీకరించ ఇవ్వగలరు

2) ఈ రిపోర్ట్ hospital నుండి బరి అయినట్లు కంటే MLC రిజిస్ట్రీ ఆఫ్ మెడికల్ బస్ లివారాలు ఎందుకు రయిత్రా తెలుపు X-Ray ఆసిస్ట్ రిజిస్ట్రీ కూడ నమోదు చేయలేదు ఎందుకు నమోదు చేయలేవ తెలుపుగలరు

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **12-07-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Letter dated 11-08-2021 requested the appellant to approach the CHC., Marpalle for the sought information.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-03-2022 at 10.30 AM.**

The Case is heard on 22-03-2022. The appellant is absent. The PIO/ Dr.D.Prashanth Kumar, Civil Assistant Surgeon, O/o the CHC, Marpalle Mandal, Vikarabad District is present and stated that the information sought by the appellant is ready and requested the Commission to provide them 2 days of time to furnish the information to the appellant.

Heard the PIO perused the material papers available on record. The Commission observed that PIO has not furnished the information to the appellant.

The Commission took a serious view against Public Information Officer for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Hence the Commission directs the PIO to furnish the information to the appellant within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
