

Order

Sri Md. Shadul has filed second appeal dated **08-09-2021** which was received by this Commission on **09-09-2021** for not getting the information sought by him from the Public Information Officer/ The Head Master, ZPHS., Kuknoorpally, Kondapaka Mandal, Siddipet District and the First Appellate Authority/ the District Educational Officer, Siddipet District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **22-04-2021** before the Public Information Officer/O/o the District Educational Officer, Siddipet District requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

 - 3) Z.P.H.S. పాఠశాలకు 2018 జనవరి నుండి 2020 జనవరి వరకు ముఖ్యము బిజినెస్ వర్క్ లకు వెళ్ళుట వంటి వివరాలు, వారికి ఇచ్చిన వాటి జీవితము, వివరాలు, ముఖ్యము ఇచ్చిన జీవితములు, వారి జీవితము వాటి జీవితములు. కృతకంగా ఉంచుటలను.
 - 4) Z.P.H.S. పాఠశాలకు 2017 నుండి జనవరి నుండి 2020. కొంతమంది వారు పరిశోధన (సంబంధించి సుగమ) సుగమ (సంబంధించి) ఉంచుటలను వివరాలు, సుగమ వర్క్ జీవితము, వారి సంబంధించి ఉంచుటలను, ఇతర విద్యార్థులు, TA, DA, లు L.T.C. లు వివరాలు, వారి సంఖ్యలను, సుగమ ఉపాధ్యక్షులను వివరాలు, వారి సంఖ్యలను.

The Public Information Officer through Letter dated 23-04-2021 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ The Head Master, ZPHS., Kuknoorpally, Kondapaka Mandal, Siddipet District requested to furnish the available information to the applicant under intimation to their office.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **30-06-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Letter dated 01-07-2021 directed the Public Information Officer to furnish the sought information to the appellant under intimation to their office.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-02-2022 at 10.30 AM.**

The Case is heard on 22-02-2022. The appellant is absent. The PIO/Smt. M.Sharadha, GHM Gr-II, ZPHS, Kukunoorpally, Kondapak, Siddipet District is present and stated that vide letter No.146, dated.13-09-2021 the information was furnished to the appellant through registered post. The PIO also submitted a copy of the information along with the copy of the postal receipt as a proof of dispatch. Sri L.Venkateshwar Reddy, Assistant Director on behalf of the First Appellate Authority/District Educational Officer, Siddipet District is present and stated that the 6(1) application was transferred to the PIO/HM, ZPHS Kukunoorpally, Kondapak, Siddipet District to furnish the information directly to the appellant.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
