## **Order**

Sri P. Srinivas has filed second appeal dated **31-08-2021** which was received by this Commission on **14-09-2021** for not getting the information sought by him from the Public Information Officer/ O/o the General Manager, SCCL., Srirampur Area, Mancherial District and the First Appellate Authority/ O/o the General Manager, SCCL., Srirampur Area, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **30-04-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Dear Sir/Madam, Please provide the below information

I request you to provide my father Late Porandla Venkatanarayana (Desig. fitter, RK5 Inc, SRP Area, EC. No: 2532574) information.

Please provide the below information in Hard Copy.

- 1) CMPF details withdraw in 2012 (Before death)
- 2) CMPF Amount credited to the Nominee Account (After Death)
- 3) Service Amount /Gratuity Amount after his death
- 4) Pension Amount allotted to the Nominee(Porandla Lalitha)

Please intimate me for any additional payments to be made for above information.

The Public Information Officer through Letter dated 31-05-2021 informed to the appellant that the information sought by him cannot be furnished as per section 8(1)(j) of RTI Act, 2005.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **30-07-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-02-2022 at 10.30 AM.**

The Case is heard on 15-02-2022. The appellant is present and stated the PIO has not furnished the information. Sri M.Rajesh, Sr.Personnel Officer on behalf of the PIO/Sri P.Govinda Raju, DGM(Per), SCCL, Srirampur Area, Mancherial District is present and submitted that vide letter Ref.No:SRP/PER/RTI/25.000/3434, dated.01-06-2021 the information sought by the appellant was rejected under section 8(1)(j) of RTI Act.

Heard both the parties and perused the material papers available on record.

The Commission did not accept the plea made by the PIO and directs the PIO to verify the details of the information sought by the appellant and furnish the information within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
