Order

Sri Syed Mehdi Hasan Moosvi has filed second appeal dated **14-09-2021** which was received by this Commission on **15-09-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Department of Heritage Telangana, Gunfoundry, Hyderabad and the First Appellate Authority/ O/o the Department of Heritage Telangana, Gunfoundry, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **02-07-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) ***How many types of security guards working in the Seven Tombs since January 2015 to till date ?***
- 2) ***Furnish the names, designation, salaries and Departments of all types of security guards worked and working in the Seven Tombs since January 2015 to till date.***

The Public Information Officer through letter dated 27-07-2021 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **25-08-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **05-01-2022 at 10.30 AM.**

The Case was heard on 05-01-2022. The Appellant is absent. The PIO/Smt.J.Amara Jyothi, Assistant Director (Admin), O/o the Department of Heritage Telangana, Hyderabad is present and stated that vide letter Lr.Rc.No.B1/793/2021, dated.27-07-2021 the information sought by the appellant was furnished. The PIO further submitted a copy of the information before the Commission.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
