Order

Sri G. Ramesh has filed second appeal which was received by this Commission on **18-09-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Commissioner of Handlooms & Textiles and AEP's., Hyderabad and the First Appellate Authority/ O/o the Commissioner of Handlooms & Textiles and AEP's., Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **10-03-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

(b) particulars of information required. : Information on the disciplinary proced. of G. Ramesh, Asst. Director (Pw) under order of dismissal.

(c) details of information received. (1): Letter R.C.No. 1307/16-E2 dated 10-1-2020 of the Director (Pw) AEPs T.S. Hyderabad along with Statement of Appeal remarks sent to Government on the appeal petition dated 27-06-2019. Of G. Ramesh, Asst. Director - Pw. T.S.

The Public Information Officer through Letter dated 15-04-2021 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **30-04-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Letter dated 24-05-2021 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **04-01-2022 at 10.30 AM**.

The Case was heard on 04-01-2022. The appellant is absent. The PIO/Smt.G.Nagalatha, Deputy Director, O/o. the Commissioner of Handlooms & Textiles and AEPs, Hyderabad and the FAA/Sri P.Venkatesham, Additional Director, O/o. the Commissioner of Handlooms & Textiles and AEPs, Hyderabad are present and submitted that vide letter Lr.Rc.No.906/2021-N2, dated. 24-05-2021 the information sought by the appellant was furnished through registered post. The PIO further submitted a copy of the information along with the copy of the postal receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
