Order

Ms. M. Shobha Rani has filed complaint dated **11-09-2021** which was received by this Commission on **22-09-2021** for not getting the information sought by him from the Public Information Officer/ O/o the District Educational Officer, Ranga Reddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **09-07-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the complainant did not get any response from the Public Information Officer, she preferred this complaint before the Commission requesting to arrange to furnish the information sought by her u/s 18(1) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **02-02-2022 at 11.00 AM.**

The appellant responded and stated that the PIO has not furnished the information.

The PIO/Smt.Nandu Sukeshini, Assistant Director, O/o the DEO, Rangareddy District responded and stated that vide Lr.No.86/(A5)A4/RTI/2021, dated.29-09-2021 the information sought by the appellant was furnished through registered post. The PIO also filed a copy of the information along with the postal receipt as a proof of dispatch.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
