Order

Sri Md. Sujath Ahmed has filed second appeal dated **14-09-2021** which was received by this Commission on **25-09-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Telangana State Industrial Infrastructure Corporation Ltd., Hyderabad and the First Appellate Authority/ O/o the Telangana State Industrial Infrastructure Corporation Ltd., Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **09-10-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

I would like to bring a few lines for your kind consideration that provides me the copies of Entire Note File & Current File No.303/A3/lands/APIIC/75 in which the case has been dealt relates to land to an extent of Ac.19.67 Gts in Sy.No.96/A/1 of BaghHayathnagar village, Hayath Nagar Mandal & Sy.No.6 & 7 of Mansoorabad village, Saroor Nagar Mandal, Ranga Reddy District.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **17-12-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Order Appeal No. 51355/RTI ACT,2005/TSIIC/APPEAL-21/2020 dated 26-02-2021 informed that the Public Information Officer/ZM., Shamshabad has furnished available information to the appellant vide letter dated.16-01-2021. Accordingly, the appeal is closed.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **04-01-2022 at 10.30 AM.**

The Case was heard on 04-01-2022. The appellant is present and stated the PIO has not furnished the information. The PIO/ Smt.B.Sunitha Bai, CGM(AM), O/o the Telangana State Industrial Infrastructure Corporation ltd., Hyderabad and the FAA/Sri K.Shyam Sunder, Chief Engineer, O/o the Telangana State Industrial Infrastructure Corporation ltd., Hyderabad are present and submitted a letter No.51353/RTI Act, 2005/TSIIC/Appeal-19/2020, dated.31-12-2021 stating that the first appeal was heard by the Appellate Authority on 22-01-2021 and orders were passed as “ The information sought cannot be furnished to the appellant as the same is exempted under Section 8(1) of the RTI Act”.

Heard both the parties and perused the material papers available on record. Since the information sought by the appellant is a public document the Commission did not accept the submission made by the Public Information officer.

Hence the Commission directs the PIO to call the appellant for verification of record as per section 2(j) of the Act by issuing prior intimation to the appellant and furnish the information following the guidelines of Section 8, 9, 10 & 11 of RTI Act by collecting the requisite charges from the appellant and to report compliance to the Commission.

With the above direction, the appeal is closed.
