Order

Sri Sambasivaw Raav has filed complaint dated **17-10-2019** which was received by this Commission on **17-10-2019** for not getting the information sought by him from the Public Information Officer/ The Superintendent, O/o the Gandhi Hospital, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **07-09-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- 2) WHO, Government of India, TS and IMA guidelines. The Total no. of patients will be treated by Specialist / Doctor. Ration also.
- a) The Total patients are being treated by Specialist / Doctor in Gandhi Hospital. The Vacant position list of all departments.
- c) The Time, day and date, to meet MS. the needed patients.
- d) The Ultrasound Redressal Mechanism in Gandhi Hospital & at each HOP and MS Office. Date of Ultrasound meeting
- 3) Based on my OP charts of Gandhi Hospital. the list of needed examinations, date, Dept. and Specialist like check findings. to save my life & General Health condition information to me
- 4) The patient Medical Attendance Rules, procedure to get treatment and Medicines, once in a month to old patients
- 5) The total Complaints, Ultrasound letters, x-ray sent are received since 1-1-2000 to 30-9-2019, Belkad, Pending.
- 6) No Medicines, no cleaning, no drinking water, no sitting chairs at OPD Rooms, no required specialist and staff. the ongoing. Noted health action taken since 1-1-2000. Under staffs

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **20-04-2021 at 10.30 AM**.

The case was heard on 20-04-2021. The complainant was absent. The Public Information Officer was also absent. Hence, the case was **adjourned**.

In view of the above, notice is issued to both the parties to attend for hearing on **08-03-2022 at 10.30 AM**.

The case is heard on 08-03-2022. The complainant is present and stated that the PIO has not provided the compensation amount as directed by the Commission in Appeal No.6047/SIC-MVN/2016, Order dated.17-05-2016. The PIO/O/o. the Superintendent, Gandhi Hospital, Secunderabad is absent.

The Commission perused the material papers available on record and observed that the PIO has not followed the directions of the Commission and was also absent for hearing even after the receipt of notice from the Commission. The Commission took a serious view against the PIO and directs to issue **Show Cause Notice** to the PIO.

The Commission also directs the First Appellate Authority/Superintendent, Gandhi Hospital to submit his explanation in person within one week from the date of receipt of this order for not taking any action against the Public Information officer in implementing the RTI Act and also for his(PIO) absence for hearing even after the receipt of the notice from the Commission.

The Commission also directs the present PIO to collect the compensation amount from the concerned public authority as per Section 19(8)(b) of RTI Act and furnish the same to the complainant within two weeks from the date of receipt of this order and to report compliance to the Commission. The action on **Show Cause Notice** will be dealt separately.

With the above direction, the complaint is closed.
