Order

Sri B. Laxman has filed second appeal dated **24-09-2021** which was received by this Commission on **27-09-2021** for not getting the information sought by him from the Public Information Officer/ the Mandal Educational Officer, Shamshabad Mandal, Rangareddy District and the First Appellate Authority/ the District Educational Officer, Rangareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **19-02-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- ① నంబూరి మండల ప్రాథమిక విద్యార్థుల జాబితా తెలియజేయమని కోరారు.
- ② నంబూరి మండల ప్రాథమిక విద్యార్థుల జాబితా గురించి ఏమిటి? - అందులో కుటుంబ సంరక్షకాధికారి గురించి వివరాలు, నల్లకోడలి, బాంబు గురించి వివరాలు.
- ③ ప్రాథమిక విద్యార్థుల జాబితా కుటుంబ సంరక్షకాధికారి, కుటుంబ సంరక్షకాధికారి గురించి వివరాలు తెలియజేయమని కోరారు.
- ④ 2010-2020 మధ్య కాలంలో నంబూరి మండల ప్రాథమిక విద్యార్థుల జాబితా తెలియజేయమని కోరారు. అందులో కుటుంబ సంరక్షకాధికారి, బాంబు గురించి వివరాలు తెలియజేయమని కోరారు.
- ⑤ ప్రాథమిక విద్యార్థుల జాబితా తెలియజేయమని కోరారు. అందులో కుటుంబ సంరక్షకాధికారి, బాంబు గురించి వివరాలు తెలియజేయమని కోరారు.
- ⑥ నంబూరి మండల ప్రాథమిక విద్యార్థుల జాబితా తెలియజేయమని కోరారు. అందులో కుటుంబ సంరక్షకాధికారి, బాంబు గురించి వివరాలు తెలియజేయమని కోరారు.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **05-08-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-02-2022 at 10.30 AM.**

The Case is heard on 22-02-2022. The appellant is absent. The PIO/ Sri D.Ram Reddy, Mandal Educational Officer, Shamshabad Mandal, Rangareddy District is present and stated that vide letter Lr.No.069/S3/RTI/2021, dated. 25-02-2021 the information sought by the appellant was furnished through registered post but the same was returned by the postal Department as “no such person”. The PIO further filed a copy of the information along with the copy of the postal receipt as a proof of dispatch. The PIO/ Smt.Nandu Sukeshini, Assistant Director, O/o the District Educational Officer, Rangareddy District is present and stated that vide letter Rc.No.126/A5/2021, dated.18-08-2021 the 6(1) application was transferred U/s.6(3) of RTI Act to the PIO/ Mandal Educational Officer, Shamshabad, Rangareddy District to furnish the information directly to the appellant.

Heard the PIO and perused the material papers available on record. The Commission observed that PIO has furnished the information to the appellant by registered post but the same was returned by the Postal Department as “no such person”.

In view of the above, the appeal is closed.
