Order

Sri P. Praveen Kumar has filed second appeal dated **21-09-2021** which was received by this Commission on **30-09-2021** for not getting the information sought by him from the Public Information Officer/ the Deputy Tahsildar, Nawabpet Mandal, Vikarabad District and the First Appellate Authority/ the Revenue Divisional Officer, Vikarabad, Vikarabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **21-06-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **12-08-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The Public Information Officer through Lr.No. C/823/2021 dated 30-08-2021 informed that on any working day between 01-09-2021 to 15-09-2021 the applicant can come for inspection of related records in their office.

Stating that the appellant was not satisfied with the reply of the Public Information Officer and did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **09-02-2022 at 10.30 AM.**

The Case is heard on 09-02-2022. The appellant is absent. The PIO/ Sri K.Ramesh Kumar, Naib Tahsildar, Nawabpet Mandal, Vikarabad District is present and stated that vide letter No.C/823/2021, dated.30-08-2021 the appellant was called for verification of records. The PIO further vide letter Lr.No.B/134/2022, dated.08-02-2022 stated that the appellant has verified the records and has received the information in which he is interested.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has failed to show any proof of the acknowledgement of the appellant stating that he has received the information.

Hence the Commission directs the PIO to once again call the appellant for verification of records as per Section 2(j) of RTI Act by issuing a prior intimation to the appellant and furnish the sought information within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
