Order

Sri Reddy Venkata Vara Prasada Rao has filed complaint dated **25-09-2021** which was received by this Commission on **30-09-2021** for not getting the information sought by him from the Public Information Officer/ The Mandal Educational Officer, Hayathnagar Mandal, Ranga Reddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **06-08-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

1. Your Office website address, mail address, appellate authority address with all details (phone, mail, address details)
2. Valid reasons for not putting COMPLAINT BOX in the premises
3. Certified copy of the letter submitted by Loyola High School, Vanasthalipuram with regards to closure of Loyola Model School (one of their branch) situated at Sarada Nagar (the principal Sri Murthy and other staff cheating / mis leading the parents duly, saying the above words with malafide intention ; to bring their criminal conspiracy to the notice of the Constitutional bodies it is required sir)
4. Number of Transfer certificates issued by LOYOLA MODEL SCHOOL, Sarada Nagar branch in the following format (as the school issued TCs duly harassing parents / manipulating the students.info site, cheating the government this information required)

Name of the student	TC issued for the year 2020-21	Fee collected for 2020-21 academic year	Number of days the student attended online classes

5. Telangana Government time norms / time boundary to issue Transfer Certificate after receipt of written request from the Parent (as Loyola school totally violating the guidelines and harassing the parents during this carona pandemic this information required)
6. Number of days Loyola Model School, Sarada Nagar worked as per your records for the year 2019-20 and 2020-21 academic years
7. Certified copies of the latest 3 visit reports of MEO, Hayatnagar to LOYOLA HIGH SCHOOL branches (model school, Montessori and in any other name)
8. Loyola high school, Vanasthalipuram compiled all the data upto date as per the Telangana Government guidelines. If not, list of issues for which Loyola High School not submitted the data within time frame / punishments imposed by you

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **02-02-2022 at 11.00 AM.**

The complainant responded and stated that the PIO has not furnished the information.

The PIO/Sri.Heerya Naik, Mandal Educational Officer, Hayathnagar Mandal, Rangareddy District responded and submitted that vide letter dated. Nil the information sought by the complainant was furnished through registered post. The PIO also filed a copy of the information along with the postal receipt as a proof of dispatch.

Heard both the parties and perused the material papers available on record the Commission observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the Complaint is closed.
