Order

Sri Reddy Venkata Vara Prasada Rao has filed complaint dated **25-09-2021** which was received by this Commission on **30-09-2021** for not getting the information sought by him from the Public Information Officer/ The Mandal Educational Officer, Hayathnagar Mandal, Ranga Reddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **06-08-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

1. Detailed guidelines with regards to fee structure decided by the Telangana Government for private schools for the year 2020-21 from the STUDENTS, who are not attended EVEN A SINGLE CLASS alongwith related circular/ DEO instructions
2. MEO powers to punish the management of Private School , who violated Govt. guidelines in the above issue
3. Staff (both teaching and non teaching) worked in LOYOLA HIGH SCHOOL in the following format (for all their branches) for the academic year 2019-2020

4. Staff (both teaching and non teaching) worked in LOYOLA HIGH SCHOOL in the following format (for all their branches) for the academic year 2020-2021 (during corona pandemic)

11. Valid reasons for issuance of 2nd TC within 10 days by the LOYOLA MODEL SCHOOL (which was totally closed as per the words of the Principal Sri Murthy sir and other staff members) to REDDY JAYA NAGA SREE SAI SANTHABHIRAM

12. Valid reasons for not lifting the phone calls (from mobile numbers) of the public by the MEO , Hayatnagar (for two days due to non recharge his incoming calls are not permitted, he is lifting land phone calls)

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **02-02-2022 at 11.00 AM.**

The complainant responded and stated that the PIO has not furnished the information.

The PIO/Sri.Heerya Naik, Mandal Educational Officer, Hayathnagar Mandal, Rangareddy District responded and submitted that vide letter dated. Nil the information sought by the complainant was furnished through registered post. The PIO also filed a copy of the information along with the postal receipt as a proof of dispatch.

Heard both the parties and perused the material papers available on record the Commission observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the Complaint is closed.
