Order

Sri Reddy Venkata Vara Prasada Rao has filed complaint dated **25-09-2021** which was received by this Commission on **30-09-2021** for not getting the information sought by him from the Public Information Officer/ The Mandal Educational Officer, Hayathnagar Mandal, Ranga Reddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **06-08-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

1. Name of the staff details of MEO office , Hayatnagar in the following format

Staff Name	Designation	Working since	Present salary	Duties

- Number of complaints received with regards to TC issues in the last month (by oral / over phone / in person / written) ; along with solution given by the MEO (by orally / over phone / in written)
- Number of complaints received with regard to TC against Loyola High School , Vanasthalipuram (model high school / Montessori wing / any other branch of Loyola school) by any mode i.e., by oral / over phone / in person / written by your office
- Certified copies of registration certificate , licence renewal , names of the present management of the LOYOLA HIGH SCHOOL , Vanasthalipuram
- Valid reasons for NOT displaying PUBLIC INFORMATION OFFICER , APPELLATTE AUTHORITY details in your office duly violating RTI Rules
- Number of complaints filed / memos issued / punishments imposed against Sri Heerya Naik , Present MEO , Hayatnagar in his entire service
- Reasons for not opening the MEO office as on 09/07/2021
- Reasons for opening the MEO office at 10-45 as on 12/07/2021 (after receiving a phone call from your office staff Sri Madhukar 9948572460 only Sri Heerya Naik , present MEO personally came and open the office)
- Certified copy of the attendance register of all the staff members for the month of July ,2021
- Reasons for giving instructions to Sri Murthy Sir 9849445130, Loyola Model School Principal to collect Rs.10000/- to issue 9th class TC to ABHIRAM by the MEO (Murthy sir confirmed it , to know the veracity of Murthy sir words it is required)

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **02-02-2022 at 11.00 AM.**

The complainant responded and stated that the PIO has not furnished the information.

The PIO/Sri.Heerya Naik, Mandal Educational Officer, Hayathnagar Mandal, Rangareddy District responded and submitted that vide letter dated. Nil the information sought by the complainant was furnished through registered post. The PIO also filed a copy of the information along with the postal receipt as a proof of dispatch.

Heard both the parties and perused the material papers available on record the Commission observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the Complaint is closed.
