Order

Sri K. Ravi has filed second appeal dated **29-09-2021** which was received by this Commission on **30-09-2021** for not getting the information sought by him from the Public Information Officer/ O/o the SCCL., Manuguru Area, Bhadradri – Kothagudem District and the First Appellate Authority/ O/o the SCCL., Manuguru Area, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **21-05-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

① మణుగూరు సింగశేరి సంస్థల్ గల OC-2, OC-4, Main Check Post, G.M office పరిధిలో గల CC-కెమెరాల యొక్క ఫుజ్జీలు 01-01-2021 నుండి 21-04-2021 వరకు CD/DVD రూపంలో ఇవ్వాలను.

② మణుగూరు సింగశేరి G.M గారిని, మణుగూరు సింగశేరి నాయకులు వియే సమయంలో సంప్రదించవలెను?

③ OC-2 లో NPA కంట్రీ Tender కు అనుగుణ్య చరణాస్థి చేసుకున్న చరణాస్థి ఫారం లో పాటు, వాసు సలబ్బులైన టెండర్లు, ఇతర కృత్యాలు ప్రక్రమణ నకలు, టెండర్ లోపల ఇవ్వాలను.

④ మణుగూరు OC నుండి తనకు అనుకూలమైన ఫోటోలను లాభించు రహస్య లోపల ఇవ్వాలను.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **06-07-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **23-02-2022 at 10.30 AM.**

The Case is heard on 23-02-2022. The appellant is present and through affidavit stated that the PIO has not furnished any information. The PIO/Sri S.Ramesh, Dy.General Manager(Per), O/o the SCCL, Manuguru Area, Bhadradi Kothagudem District is present and stated that vide letter Ref.No.MNG/PER/RTI/25/1303, dated.29-06-2021 the available information was furnished to the appellant and for point No.3 the 6(1) application was transferred to the PIO/Corporate Area to furnish the information directly to the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished part information to the appellant and for Point No.3 transferred the 6(1) application to the PIO/Corporate Area to furnish the information directly to the appellant.

Hence the Commission directs the PIO/ Corporate Area to furnish the information to the appellant within one week from the date of receipt of this order through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
