## Order

Sri M. Ahmed has filed second appeal dated **27-09-2021** which was received by this Commission on **30-09-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Government General Hospital, Mahabubnagar District and the First Appellate Authority/ O/o the Government General Hospital, Mahabubnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **25-02-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

I submit to inform that I was appointed as Recorder of the A.S. Mich Mahabubnagar in the year 1982 and joined duty on 24-07-1982. This year ending, one person i.e. Shankar alias (Anji) beaten me in front of SI named Sri M.A. Razgat, in his residence at Vedanna pet Mahabubnagar and my back seriously injured and a I am felt down on the Road by SI. Shankar has help me and leave from the 21st April till out any weapon though Sri. Shankar alias (Anji) to hold a knife (Big) and informed to the Police, bring me to Dist. Hqs. Hospital on 06-12-1982 and I have 5, 6 stitches on my back. lot of blood leaked from my body and, in I am inpatient - from 06-12-1982 to 08/12/82. Therefore, I request you kindly arrange to give inpatient - certificate along with discharge summary sheet in full details for which kind of action you will take. I will be grateful to you. (M.A. Razgat (MED))

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **08-03-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-03-2022 at 10.30 AM.**

The case is heard on 22-03-2022. The appellant is absent. The PIO/O/o. the Government General Hospital, Mahabubnagar District is also absent.

The Commission perused the material papers available on record and observed that the PIO has not furnished the information and was also absent for hearing even after the receipt of notice from the Commission. The Commission took a serious view against the PIO and directs to issue **Show Cause Notice** to the PIO for not furnishing the information to the appellant and also for his absence before the Commission.

The Commission also directs the PIO to furnish the information to the appellant within one week from the date of receipt of this order through RPAD and to report compliance to the Commission. The action on **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
