Order

Sri G. Suryanarayana has filed second appeal dated **27-09-2021** which was received by this Commission on **01-10-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Hyderabad Convention Visitors Bureau, Hyderabad and the First Appellate Authority/ O/o the Hyderabad Convention Visitors Bureau, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **15-07-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. Copy of the first advertisement by Hyderabad Convention Visitor Bureau (HCVB) for the post of Chief Executive Officer.
2. Qualifications and experience required for the CEO post of HCVB.
3. Copy of the applications received in response to the advertisement released for the post of CEO, HCVB
4. Copy of the minutes of the selection committee wherein the incumbent CEO was selected.
5. Copy of the appointment letter given to the incumbent Chief Executive Officer, HCVB.
6. Total monthly remuneration and allowances being paid to the CEO, HCVB.
7. Tenure of the CEO post, HCVB.
8. Since how long the present incumbent is working as CEO, HCVB and copy of the contract of employment.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **19-08-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **05-01-2022 at 10.30 AM.**

The Case was heard on 05-01-2022. Sri Bakka Judson representative of the appellant is present. The PIO/Sri Gary Khan, CEO, Hyderabad Convention Visitors Bureau, Begumpet, Hyderabad is present and stated that the sought information is brought before the Commission and they are ready to furnish the same to appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that since the PIO did not provide the certified copy of the information the appellant refused to accept the same.

Hence the Commission directs the Public Information Officer to furnish the certified copy of the information to the appellant within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
