Order

Sri Muralidhar Reddy has filed second appeal dated **30-09-2021** which was received by this Commission on **01-10-2021** for not getting the information sought by him from the Public Information Officer/ the District Revenue Officer, Vikarabad District and the First Appellate Authority/ the Joint Collector, Vikarabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **15-02-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **22-02-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **09-02-2022 at 10.30 AM.**

The Case is heard on 09-02-2022. The appellant is absent. The PIO/Smt. Haritha Devi, Administrative Officer, O/o the District Collectorate, Vikarabad District is present and submitted her affidavit stating that the PIO/Naib Tahsildar, Doma Mandal, Vikarabad District has furnished the information directly to the appellant.

The PIO/Sri T.Rajender Reddy, Naib Tahsildar, Doma Mandal, Vikarabad District is present and submitted that vide letter Lr.No.A/253/2021, dated. 19-03-2021 the information sought by the PIO was furnished through registered post. The PIO further submitted a copy of the information but failed to provide the copy of the acknowledgement.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has failed to provide a proof of dispatch.

Hence the Commission directs the PIO to furnish the information once again through RPAD within one week and to report compliance to the Commission

In view of the above, the appeal is closed.
