## **Order**

Sri R. Raji Reddy has filed second appeal dated **29-09-2021** which was received by this Commission on **07-10-2021** for not getting the information sought by him from the Public Information Officer/ The Head Master, ZPHS (Girls), Kothapally Mandal, Karimnagar District and the First Appellate Authority/ The District Educational Officer, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **23-04-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

or Reservation) లో Select అయినారు కృషికింకా ఇచ్చినందు.  
2) ఉద్యోగ నియామక సమయంలో వీరు సమర్పించిన Caste Certificate  
నకల్ కృషికింకా ఇచ్చినందు.  
3) Appointment order నకల్ కృషికింకా ఇచ్చినందు.

The Public Information Officer through Letter dated 20-05-2021 informed to the appellant that the information sought is not available in their office.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **14-07-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **16-02-2022 at 10.30 AM.**

The Case is heard on 16-02-2022. The appellant is absent. The APIO/Sri. T.Vidyasagar Rao, Senior Teacher of School, ZPHS, Kothapally, Karimnagar District is present and stated that vide letter Lr.No.30/2021, dated.20-05-2021 the appellant was informed that the information sought by the appellant is not as per section 2(j) of the RTI Act. The PIO further submitted a copy of the letter along with the copy of the postal receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on record. The Commission observed that the information sought by the appellant does not pertain to the PIO/Head Master, ZPHS(Girls), Kothapally, KarimNagar District.

Hence the Commission advises the appellant to file a separate 6(1) application and seek information from the appropriate authority.

In view of the above, the appeal is closed.
