## **Order**

Sri K. Sarveswara Rao has filed second appeal dated **23-09-2021** which was received by this Commission on **08-10-2021** for not getting the information sought by him from the Public Information Officer/ O/o the GM, SCCL., Kothagudem Area, Bhadradri – Kothagudem District and the First Appellate Authority/ O/o the GM, SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **10-05-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

**With reference to the letter cited above, I came to know that GM (Vigilance) had sent necessary documents to your office for further action. I here enclosed a copy of letter sent by GM(Vigilance) to GM(Personnel) for taking necessary action on 23.11.2013(CRP/VIG/2013/E/740 Date:23-11-2013).**

**Although several complaints have been raised on fake identity of Sri Annam Srinivasa Rao(EC.No.0290126), no suitable action taken on him.**

Hence, I request you to furnish actions taken by you on following letters received by you.

**1.CRP/VIG/2013/E/740 Date:23-11-2013 from AGM(VIGILANCE)**

**2.CRP/VIG/2021/PIO-3341/E/254 Date:19.04.2021 from GM(VIGILANCE)**

Xerox copies of above letters are attached herewith for your reference.

The Public Information Officer through Letter dated 15-05-2021 requested the concerned authority to furnish the information on priority as the information is sought which is time bound, for onward submission to the applicant, immediately.

The Public Information Officer through Letter dated 26-05-2021 requested the Public Information Officer/ Manuguru Area to furnish the information on priority as the information is sought which is time bound, for onward submission to the applicant, immediately.

The Public Information Officer through Letter dated 05-06-2021 requested the DGM(E&M), CSP, MNG to furnish the information on priority as the information is sought which is time bound, for onward submission to the applicant, immediately.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **10-07-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Letter dated 16-07-2021 requested the Public Information Officer to furnish the sought information to the applicant under intimation to their office.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **23-02-2022 at 10.30 AM.**

The Case is heard on 23-02-2022. The appellant is present and stated that the PIO has not furnished the information. The PIO I/Sri S,Ramesh, Dy.General Manager(Per), O/o the SCCL, Manuguru Area, Bhadradri Kothagudem District is present and stated that vide Ref No.CRP/RTI-PIO/3341/483, dated.23-04-2021 the available information was furnished to the appellant.

The PIO II/ Sri D,Srinivas, Dy.GM, Corporate, Kothagudem Area is present and stated that the information sought by the appellant is third party information and vide Ref No.CRP/RTI-PIO/3382/1191, dated.20-12-2021 the same was informed to the appellant through registered post.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO/ Dy.GM, Corporate, Kothagudem Area has rejected to furnish the information to the appellant stating that the information sought falls under third party information and the same may be rejected U/s.8(1)(j) of RTI Act, 2005.

Keeping in view of the above, the appeal is closed.
