Order

Sri Madhava Rao has filed complaint dated **24-09-2021** which was received by this Commission on **08-10-2021** for not getting the information sought by him from the Public Information Officer/ The District Revenue Officer, Vikarabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **01-09-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

తెలివేస్తాను అని నా యెక్క ఫోన్ లు కూడ తీసుకొనినారు. కాని 40 రోజుల తరువాత నాకు
నాకు తమరి ప్రతినిధి కాని తమరు కాని ఎట్టి విధమైన సమాచారము తెలియచేయలేదు. నాకు
ఇట్టి విషయములో తమరు నాకు 01-07-1996 నుండి సమాచారము తెలియచేయకలర

Stating that the complainant did not get any response from the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **09-02-2022 at 10.30 AM.**

The Case is heard on 09-02-2022. The complainant is present and stated that the PIO has not furnished the sought information till date. The PIO/Smt. Haritha Devi, Administrative Officer, O/o the District Collectorate, Vikarabad District is present and stated that part information was already furnished to the complainant in the earlier complaint No.12465/SIC-MNR/2019 and the Commission vide order dated.20-07-2021 has directed the PIO to submit a specific reply for the remaining information to the complainant. Hence the PIO stated that as per the directions of the Commission the complainant was informed orally that the remaining information sought by him pertains to the PIO/O/o the RDO, Tandur Division, Vikarabad District.

The Sri P.Kiran Kumar, Naib Tahsildar on behalf of the PIO Sri Mahesh Goud, Divisional Administrative Officer, Tandur Division, Vikarabad District is present and requested the Commission to provide them one week of time to furnish the information to the complainant.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO/ O/o the RDO, Tandur Division, Vikarabad District to furnish the remaining information to the complainant within one week through RPAD and to report compliance to the Commission. If the PIO fails to comply with the instructions issued, action will be taken against the PIO as per Section 20 of the RTI Act, 2005.

With the above direction, the complaint is closed.
