Order

Ms. S. Suguna has filed second appeal dated **20-10-2021** which was received by this Commission on **20-10-2021** for not getting the information sought by him from the Public Information Officer/ The Mandal Educational Officer, Shankarpally Mandal, Ranga Reddy District and the First Appellate Authority/ The District Educational Officer, Rangareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **03-08-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- ii) K.పెండ్లపాటి డాక్టర్ గా పనిచేసినట్లు మరియు (తనకు) కేసులో
ప్రస్తుతం ఉన్న సమస్యలను తెలియజేయవలసిందిగా
అభ్యర్థించారు.

Stating that the appellant did not get any response from the Public Information Officer, she filed 1st appeal dated **08-09-2021** before the First Appellate Authority requesting him to furnish the information sought by her u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, she preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **02-02-2022 at 11.00 AM.**

The appellant responded and stated that the PIO has not furnished the information.

The PIO/Sri.Syed Akbar, Mandal Educational Officer, Shankarpally Mandal, Rangareddy District responded and requested the Commission to provide them one week of time to furnish the information.

Heard both the parties and perused the material papers available on record the Commission observed that the PIO has not furnished the information to the appellant. The Commission took a serious view against the PIO and thereby directs to issue **Show Cause Notice** to the PIO for not furnishing the information to the appellant.

The Commission also directs the PIO to furnish the information to the appellant following the guidelines of Section 8, 9, 10 & 11 of RTI Act, 2005 within one week through RPAD and to report compliance to the Commission. The order on **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
