Order

Ms. S. Suguna has filed second appeal dated **20-10-2021** which was received by this Commission on **20-10-2021** for not getting the information sought by him from the Public Information Officer/ O/o the District Educational Officer, Ranga Reddy District and the First Appellate Authority/ The District Educational Officer, Rangareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **04-08-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1) DSC - 2002 పంపిణీ జిల్లా లో నియమించబడిన పోస్టులు
Hindi/Indi... catagori (పాఠశాల, అభివృద్ధి) ప్రకటన నాకు. ~~Copy~~ Copy
Certified copy పంపించండి.

Stating that the appellant did not get any response from the Public Information Officer, she filed 1st appeal dated **08-09-2021** before the First Appellate Authority requesting him to furnish the information sought by her u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, she preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **02-02-2022 at 11.00 AM.**

The appellant responded and stated that the PIO has not furnished the information.

The PIO/Smt.Nandu Sukeshini, Assistant Director, O/o the DEO, Rangareddy District responded and submitted a letter Lr.No.123/(A5)A4/RTI/2021, dated.29-01-2022 stating that the information sought by the appellant was furnished through registered post. The PIO also filed a copy of the information along with the postal receipt as a proof of dispatch.

Heard both the parties and perused the material papers available on record. The Commission observed that though the PIO has furnished the information to the appellant but the appellant claims that he has not received the certified copy of the information sought by him.

Hence the Commission directs the PIO to furnish he certified copy of the information sought by the appellant within one week through RPAD and to report compliance to the Commission. If the PIO fails to comply with the instructions issued, action will be initiated against the PIO as per Section 20 of RTI Act.

With the above direction, the appeal is closed.
