Order

Sri Alok Barua filed complaint dated **16-10-2021** which was received by this Commission on **20-10-2021** stating that the Public Information Officer/ O/o the YAT&C., Hyderabad did not implement the Commission Order in Complaint No. 11094/SIC/2020 dated 03-08-2021.

The complainant stated that he was not satisfied with the reply of the Public Information Officer, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **05-01-2022 at 10.30 AM.**

The Case was heard on 05-01-2022. The complainant is present and stated that the PIO has furnished only part information. The PIO/Smt. K.Latha, Assistant Secretary to Government, Youth Advancement, Tourism & Culture Department, T.S.Secretariat, Hyderabad is present and through affidavit stated that after receipt of the directions from the Hon'ble Commissioner in case No.11094/SIC-MNR/2020, dated.03-08-2021 vide letter No.1384/T&PMU/A2/2019, dated. 08-10-2021 the available information was furnished to the complainant through registered post and for remaining information transferred the 6(1) application to the PIO/O/o the Telangana State Tourism Development Corporation, Hyderabad. The PIO further submitted a copy of the information along with the copy of the postal receipt.

Heard both the parties and perused the material papers available on record. The Commission observed that the complainant has not received information for point No.III of his 6(1) application dated.08-05-2019.

Hence the Commission directs the PIO/ O/o the Telangana State Tourism Development Corporation, Hyderabad to furnish the information for point No.III by calling the complainant for verification of record as per section 2(j) of the Act by issuing prior intimation to the complainant and furnish the information following the guidelines of Section 8, 9, 10 & 11 of RTI Act within one week through RPAD and to report compliance to the Commission.

With the above direction, the complaint is closed.
