Amended Order

Sri N.Komuraiah has filed second appeal dated **31-10-2019** which was received by this Commission on **14-11-2019** for not getting the information sought by him from the Public Information Officer/ The Singareni Main Hospital, O/o the SCCL., Kothagudem, Bhadradri – Kothagudem District and the First Appellate Authority/ O/o the SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **26-07-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

నేను అనారోగ్యం కారణంగా తేది: 17-10-2007 రోజున సింగరేణి మేయిన్ హాస్పిటల్, కొత్తగూడెం యందు అడ్మిట్ అయినాను. నా యొక్క IP No. 5278. నేను ఇట్టి హాస్పిటల్ యందు తేది: 17-10-2007 నుండి 25-10-2007 వరకు వైద్య చికిత్సలు చేయించుకోవడం జరిగినది.

కావున తేది: 17-10-2007 రోజు నుండి తేది: 25-07-2007 వరకు నాకు చేసిన వైద్య చికిత్సల రిపోర్టులు మరియు P.M.E. రిపోర్టులను సర్టిఫైడ్ చేసి ఇవ్వగలరని నా యొక్క ప్రార్థన

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **05-09-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The case was heard on 19-04-2021. The appellant was absent. The Public Information Officer was present. The Public Information Officer submitted that a letter dated.31-03-2021 has been forwarded to the appellant stating that they were unable to trace out the record sought by the appellant. Since the appellant was absent. The case is **adjourned**.

In view of the above, with a request to both the parties to attend for hearing on **20-07-2021 at 10.30 AM**.

The Case was heard on 20-07-2021. The appellant was heard through telephonic call and stated that the PIO has not furnished the information till date. The PIO/ Sri Dhanapal Srinivas, Dy.G.M.(PER)/Welfare & CSR, O/o. SCCL, Bhadradi Kothagudem District is present and stated that the appellant is seeking information relating to 13 years old records. Moreover the Singareni Main Hospital maintain records for only 10 years. The PIO further submitted that a letter Ref.No.CRP/MED/RTI ACT/2021/6309, dated.13-07-2021 has been forwarded to the appellant stating that the record/discharge summary sought by him is already submitted to the one at the time of discharge from main hospital.

The Commission perused the material papers available on record and observed that the PIO has furnished the information to the complainant is seeking information relating to 13 years old record and PIO stated that every patient will be given their discharge summary during the time of discharge. In view of the above, the appeal is closed.
