Order

Sri P. Prashanth has filed second appeal dated **15-11-2019** which was received by this Commission on **15-11-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Gandhi Hospital, Hyderabad and the First Appellate Authority/ O/o the Director of Medical Education, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **25-07-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) Total number of house surgeons from gandhi medical college and other private medical college present.there full detaial list
- 2) i request you sir please kindly give the biometric attendance of transfer internees and gandhi internees .
- 3) i request you sir please kindly give the concerned departments attendance by month wise where they did the posting.
- 4) how Many house surgeons did not attend the complete internship in year 2018- 2019
- 5) how many internees given extention ,and till now how many are issued the internship certificate sir please give the list of internees with the certificate number of gandhi hospital.
- 6) Who is the incharge officer of the house surgeons for year 2018 -2019.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **04-09-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Lr.Rc.No. 387633 to677/2019 dated 14-09-2019 requested the Public Information Officer/ Osmania General Hospital and the Public Information Officer/ Gandhi Hospital to provide the point wise information directly to the applicant.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **20-04-2021 at 10.30 AM.**

The case was heard on 20-04-2021. The complainant was present. The Public Information Officer was absent. Hence, the case was **adjourned.**

In view of the above, notice is issued to both the parties to attend for hearing on **08-03-2022 at 10.30 AM.**

The case is heard on 08-03-2022. The appellant is absent. The PIO/O/o. the Superintendent, Gandhi Hospital, Secunderabad is also absent.

The Commission perused the material papers available on record and observed that the PIO has not furnished the information and was also absent for hearing even after the receipt of notice from the Commission. The Commission took a serious view against the PIO and directs to issue **Show Cause Notice** to the PIO for not furnishing the information to the complainant.

The Commission also directs the First Appellate Authority/Superintendent, Gandhi Hospital to submit his explanation in person within one week from the date of receipt of this order for not taking any action against the Public Information officer in implementing the RTI Act and also for his absence for hearing even after the receipt of the notice from the Commission.

The Commission also directs the PIO to furnish the information to the appellant within one week from the date of receipt of this order through RPAD and to report compliance to the Commission. The action on **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
