Order

Sri Mohd. Imran has filed second appeal dated **27-10-2021** which was received by this Commission on **28-10-2021** for not getting the information sought by him from the Public Information Officers/ O/o the District Survey & Land Records, Vikarabad District and the Public Information Officer/ O/o the Tahsildar, Dharur Mandal, Vikarabad District and the First Appellate Authority/ the District Revenue Officer, Vikarabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **24-06-2021** before the Public Information Officer/ O/o the District Collector, Vikarabad District requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

I therefore request the state public information officer, collectorate Vikarabad Dist. To furnish following records under section 6 (1) of R.T.I.A of 2005, relating to old survey No. 112 & new survey No. 125 of Dharoor Mandal, Dharoor Village issued to records certified copies

- 1. P.T. register**
- 2. Setwar for the year 1954-58**
- 3. Chow fasla for the year 1954-1958 & 1975-76**

The Public Information Officer through Letter dated 02-07-2021 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ O/o the District Survey Officer, Vikarabad District and the Public Information Officer/ O/o the Tahsildar, Dharur Mandal with a request to furnish the information to the appellant directly under intimation to their office.

The Public Information Officer/ District Survey & Land Records, Vikarabad District through Letter dated 08-07-2021 informed to the appellant that on verification of technical records of Dharur Village & Mandal, the Sethwar for Sy.No. 125 is not available.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **10-08-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **09-02-2022 at 10.30 AM.**

The Case is heard on 09-02-2022. The appellant is present and stated that the PIO has furnished part information. The PIO/Sri M.Ram Reddy, District Officer, Survey & Land Records, Vikarabad is present and stated that vide Lr.No.K3677/VKB/2021, dated.08-07-2021 the appellant was informed that on verification of technical records of Dharur Village & Mandal, the sethwarior sought by him is not available.

Sri J.Dashrath Singh, Senior Assistant on behalf of the PIO/Naib Tahsildar, Dharur Mandal, Vikarabad District is present and stated that vide Lr.No.A/130/2022, dated.08-02-2022 the available information was furnished to the appellant personally on the day of hearing. The PIO also submitted a copy of the information personally endorsed by the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO/ Naib Tahsildar, Dharur Mandal, Vikarabad District has furnished the available information to the appellant.

Since the information is furnished, the appeal is closed.
