Order

Sri G. Raju has filed complaint dated **25-10-2021** which was received by this Commission on **29-10-2021** for not getting the information sought by him from the Public Information Officer/ O/o the DM&HO., Mahabubabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **04-09-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

01. మీ శాఖ పరిధిలోని 2017 నుండి ఆగస్టు, 2021 వరకు క్రింద సమాచారం పూర్తి వివరాలతో ఇవ్వగలరు.
02. ఎన్‌హెచ్‌ఎం పథకం కింద జిల్లాకు వచ్చిన నిధుల వివరాలు, ఖర్చు చేసిన పూర్తి వివరాలు, ఇతర నిధులకు సంబంధించిన ఖర్చులు, పనుల వారిగా పూర్తి వివరాలు
03. ఇతర ఆఫీసు ఖర్చులకు వచ్చిన నిధులు ఖర్చు చేసిన పూర్తి వివరాలతో నకల పత్రాలు
04. ఊర్లకు వెళ్లేందుకు ఆఫీసర్లు ఉపయోగిస్తున్న వెహికల్ వివరాలు, వాటికి సంబంధించిన బిల్లులు
05. పై వివరాలకు సంబంధించిన పనుల పూర్తి వివరాలతో సీడి / పెన్‌డ్రైవ్ రూపంలో లేక ఈ మెయిల్ ద్వారా సమాచారం ఇవ్వగలరు.

The Public Information Officer through letter dated 09-09-2021 informed to the appellant that to furnish the sought information he has to pay a requisite amount of Rs. 1000/- for Xerox copies/ attested copies.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-03-2022 at 10.30 AM.**

The Case is heard on 22-03-2022. The complainant is absent. The PIO/ Sri G.Chingoji, Senior Assistant, O/o the DM & HO, Mahabubabad District is present and stated that vide letter Rc.No.A1/138/2022, dated.09-02-2022 the information sought by the complainant was furnished personally to the complainant in their office. The PIO further filed a copy of the information along with the personal endorsement of the complainant.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
