## Order

Sri A. Gangadhar has filed complaint dated **26-11-2019** which was received by this Commission on **30-11-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Department of Mines & Geology, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **21-08-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- 1] C.C. of information about the entire revision petitions are covered under the demand notices of Asst. Director, Mines & Geology Vigilance, Karimnagar copies of revision petitions along with the orders covered under the Memo No.6665/R1/2016 dated 15-07-2016, issued by the Govt. of Telangana, Dept. of Mines & Geology.
- 2] C.C. of appraisal report No.60 (268/NR-1/2013) dated 29-05-2013, which is covered as a Ref.No.1 in Memo No.6665/R1/2016 dated 15-07-2016, issued by the Govt. of Telangana, Dept. of Mines & Geology along with entire details.
- 3] C.C. of Memo No.4191/M1(2)/2016 dated 03-05-2016, as mentioned in Ref.No.2 in Memo No.6665/R1/2016 dated 15-07-2016, issued by the Govt. of Telangana, Dept. of Mines & Geology.
- 4] C.C. of orders issued by Govt. of Telangana dated 12-06-2016 is mentioned in Ref.No.3 in Memo No.6665/R1/2016 dated 15-07-2016, issued by the Govt. of Telangana, Dept. of Mines & Geology.
- 5] C.C. of information about the payment of Seigniorage collected from M/s Swetha Agencies, Karimnagar as per the appraisal report vide No.60 (268/NR-1/2013) dated 29-05-2013 which is covered in Memo No.6665/R1/2016 dated 15-07-2016, issued by the Govt. of Telangana, Dept. of Mines & Geology, the details to be furnished.
- 6] C.C. of information about the payment of Seigniorage collected from M/s Swetha Agencies, Raghavapuram as per the appraisal report vide No.60 (268/NR-1/2013) dated 29-05-2013 which is covered in Memo No.6665/R1/2016 dated 15-07-2016, issued by the Govt. of Telangana, Dept. of Mines & Geology, the details to be furnished.
- 7] C.C. of information about the payment of Seigniorage collected from M/s A.S. Shipping (P) Ltd., Uppal, Peddapalli, Gangadhara as per the appraisal report vide No.60 (268/NR-1/2013) dated 29-05-2013 which is covered in Memo No.6665/R1/2016 dated 15-07-2016, issued by the Govt. of Telangana, Dept. of Mines & Geology, the details to be furnished.

**(5) more points.**

The Public Information Officer through Letter dated 21-10-2019 informed that the information requested by the complainant cannot be furnished as the matter is sub-judice and it covered by a public interest litigation and pending in the Hon'ble Court.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **16-03-2022 at 10.30 AM.**

The case is heard on 16-03-2022. The complainant is absent. The PIO/Smt.M.Vijaya Vani, Assistant Director, O/o the Department of Mines & Geology, Hyderabad is present and stated that vide letter Lr.No.3441/E/2005, dated. -09-2019 the Assistant Director of Mines & Geology, Karimnagar has furnished the part information to the complainant and for remaining information vide letter No.DMG-E2/RTI/75/2019-DMG, dated.21-10-2019 the complainant was informed that the required information cannot be furnished as the matter is sub-judice and is pending in the Hon'ble Court.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO/Assistant Director of Mines & Geology, Karimnagar has furnished the part information to the complainant and for remaining information the PIO/ Assistant Director of Mines & Geology, Hyderabad has informed that remaining information is sub-judiced.

Hence the Commission directs the PIO/ Assistant Director of Mines & Geology, Hyderabad to furnish the information to the complainant immediately after the receipt of the orders from the Court of law and to report compliance to the Commission.

With the above direction, the complaint is closed.
