Order

Sri B. Varun has filed second appeal dated **09-11-2021** which was received by this Commission on **10-11-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Commissioner of Industries, Abids, Hyderabad and the First Appellate Authority/ O/o the Commissioner of Industries, Abids, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **09-08-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- a) Issue me the certified copies of permission **031260 / 11 / U 6 / HMDA / 02122019** issued by Telangana State Industrial Project Approval & Self Certification System (TS – iPASS).
- b) Issue me the certified copies of the supporting documents which are related to the permission **031260 / 11 / U 6 / HMDA / 02122019**.
- c) Issue me the certified copies of permission's issued in Survey Number's **99 and 100** of Antaipalle or Anthaipally Village, Shamirpet Mandal, Medchal – Malkajgiri District issued by TS – iPASS.
- d) Issue me the certified copies of the supporting documents which are related to the permission's issued in Survey Number's **99 and 100** of Antaipalle or Anthaipally Village, Shamirpet Mandal, Medchal – Malkajgiri District.
- e) Issue me the certified copies of permission's issued in Survey Number's **99 P and 100 P** of Antaipalle or Anthaipally Village, Shamirpet Mandal, Medchal – Malkajgiri District issued by TS – iPASS.
- f) Issue me the certified copies of the supporting documents which are related to the permission's issued in Survey Number's **99 P and 100 P** of Antaipalle or Anthaipally Village, Shamirpet Mandal, Medchal – Malkajgiri District.

The Public Information Officer through Letter dated 30-08-2021 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **22-09-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **04-01-2022 at 10.30 AM.**

The Case was heard on 04-01-2022. The appellant is absent. The PIO/ Sri M.A.Khaleel, Joint Director, O/o the Commissioner of Industries, Hyderabad and the FAA/Sri Rajkumar Ohatker, Additional Director, O/o the Commissioner of Industries, Hyderabad are present and stated that vide letter Lr.No.37/2021/1199686/1199686/FD, Dated/30-08-2021 part information was furnished to the appellant. The PIO further stated that the remaining information sought by the appellant is third party information and a letter Lr.No.37/2021/1199686/1199686/FD-1, Dated.30-08-2021 was forwarded to the third party U/s.11 of RTI Act for his consent to furnish his information but vide letter dated.12-10-2021 the third party refused to provide his personal information to the appellant. The PIO also submitted the copy of the information and also the copy of the letter from the third party.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant except for personal information of the third party as per Section 8(1)(j) of the RTI Act.

Since the information is furnished, the appeal is closed.
