Order

Sri L. Rajaiah has filed second appeal which was received by this Commission on **12-11-2021** for not getting the information sought by him from the Public Information Officer/ The Assistant Director, O/o the Mines & Geology, Peddapalli District and the First Appellate Authority/ O/o the Mines & Geology, Peddapalli District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **09-08-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) పెద్దపల్లి జిల్లాలో ఇసుక రిజర్వ్ ఎన్ని ఉన్నాయి. ఈ ఎకరేజీ ఎక్కడ ఉన్నాయి. కరచల గండ్రాట్ల పెద్ద ఎయిల్డ్
- 2) ఒత్తిడికి క్షార నుండి ఎన్ని రాజుల ఇసుక తీసుకున్నారో యాట ఎవరయి ఉన్నారు.
- 3) ఏండ్లంట్ల క్రిక్ అలాగే ఎన్ని టన్నుల ఇసుక తీసుకున్నారో - ట. పశులున్ క్రిక్ అలాగే ఎన్ని టన్నుల ఇసుక తీసుకున్నారో యాట ఎవరయి ఉన్నారు.
- 4) ఒత్తిడికి లారీ ఎన్ని టన్నుల ఇసుక తీసుకున్నారో యాట ఎవరయి ఉన్నారు.
- 5) ఇసుక ట్రాక్టర్లకు అనుమతి ఇచ్చారు. ఇది ఎక్స్టెండ్ నుండి ఎన్ని టన్నులకు అనుమతి ఇచ్చారు.
- 6) యేలీ లారీ మరయు ట్రాక్టర్లకు GPS డివైస్ అయి చెప్పారు. దీనిని అన్నింటా ఏకపాత్రా అయి యాట ఎవరయి ఉన్నారు.

The Public Information Officer through Letter dated 30-08-2021 furnished information for point no.1 and for remaining information the applicant was requested to approach the Public Information Officer/ O/o the T.S. Mineral Development Corporation Ltd., Peddapalli District.

The Public Information Officer through Letter dated 30-08-2021 forwarded the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ O/o the T.S. Mineral Development Corporation Ltd., Peddapalli District and requested to furnish the sought information to the applicant directly under intimation to their office.

The Public Information Officer/ O/o the T.S. Mineral Development Corporation Ltd., Hyderabad through Letter dated 14-09-2021 informed to the applicant the application is on Company name. Hence, the information could not be provided.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **25-09-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **04-01-2022 at 10.30 AM.**

The Cases were heard on 04-01-2022. The appellant is absent. The PIO/ Sri R.Sainath, Assistant Director, Mines & Geology, Peddapalli District is present and stated that the appellant is seeking information for 6 points and vide letter No.54/RTI Act/2016, dated.30-08-2021 the information for point No.1 is furnished to the appellant and for remaining information the 6(1) application was transferred to Telangana State Mineral Development Corporation ltd., Peddapalli District to furnish the information to the appellant. The PIO/Sri M.Rajashekar, Deputy General Manager, Telangana State Mineral Development Corporation ltd., Peddapalli District is present and stated that since the appellant has filed his 6(1) application dated.09-08-2021 not with the name of an individual as per Section 3 of the RTI Act, 2005, hence rejected the application.

Heard the PIO and perused the material papers available on record. The Commission directs the PIO/O/o the Telangana State Mineral Development Corporation ltd., Peddapalli District to furnish the information to the appellant within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
