Order

Sri Y. Narsimulu has filed complaint dated **09-11-2021** which was received by this Commission on **12-11-2021** for not getting the information sought by him from the Public Information Officer/ The Deputy Tahsildar, Marpalle Mandal, Vikarabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **09-08-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

The Public Information Officer through Memo No. A/1237/2021 dated 30-09-2021 furnished available information to the appellant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **09-02-2022 at 10.30 AM.**

The Case is heard on 09-02-2022. The complainant is absent. The PIO/ Sri A.Venkata Chary, Deputy Tahsildar, Marpalle Mandal, Vikarabad District is present and stated that vide letter No.A/1237/2021, dated.30-09-2021 the available information was furnished to the complainant.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
