## **Order**

Sri Mohd Ashraf has filed second appeal dated **10-11-2021** which was received by this Commission on **15-11-2021** for not getting the information sought by him from the Public Information Officer/ O/o the District Educational Officer, Adilabad District and the First Appellate Authority/ the District Educational Officer, Adilabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **25-07-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

The Public Information Officer through Letter dated 26-08-2021 informed to the appellant that in point No. 1, 2 & 3 of Teachers seniority list is under preparation and the information is required to be obtained from the field level officers.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **01-09-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-02-2022 at 10.30 AM.**

The Case is heard on 22-02-2022. The appellant is absent. The PIO/Sri K.Narsimulu, Assistant Director, O/o the District Educational Officer, Adilabad District is present and the information sought by the appellant pertains to all the Mandal Educational Officers of the district and vide letter Rc.No.1800/A4/RTI/2021, dated.16-02-2022 the 6(1) application was transferred to all the Mandal Educational Officers to furnish the information directly to the appellant through Registered post.

Heard the PIO and perused the material papers available on record. The Commission observed that the appellant is seeking information relating to all the Mandal Educational Officers in the District.

Keeping in view of the Office Memorandum No.10/2/2008-IR, Government of India, Ministry of Personnel, Public Grievances & Pension, Department of Personnel & Training, New Delhi dated.12<sup>th</sup> June, 2008 states. The Commission is of the view that the PIO ought to have furnished the held information to the appellant and transfer the 6(1) application only to a single Public Information Officer and advised the appellant to file separate 6(1) application before the concerned MEO's, but failed to do so. The Commission warns the PIO not to repeat the same in the future.

The Commission also directs the PIO to furnish the held information to the appellant within one week through RPAD and to report compliance to the Commission.

The Commission advises the appellant to file separate 6(1) application before the concerned Mandal Educational Officer and seek the required information.

With the above direction, the appeal is closed.
