Order

Sri D. Srinivas has filed second appeal dated **22-11-2021** which was received by this Commission on **22-11-2021** for not getting the information sought by him from the Public Information Officer/ O/o the GM, SCCL., Bhupalpalli Area, Jayashankar Bhupalpalli District and the First Appellate Authority/ O/o the GM, SCCL., Bhupalpalli Area, Jayashankar Bhupalpalli District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **04-09-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. కాకత్యు ఖని Kakatya Khan - 6 Incline Bhupalpalli సంబంధ ప్రాంతం వద్ద వెళ్ళిన అవగాహన (EPD) లోని కార్యక్రమ నియంత్రణ కమిటీ అవగాహన కేంద్రం గురించి సమాచారం అందించండి, పాపా, గ్రామం, ఎవరి ద్వారా అవగాహనం కార్యక్రమం ఏర్పడినది తెలియజేయండి.
2. Kakatya Khan - 6 Incline సంబంధ కార్యక్రమ నియంత్రణ కమిటీ అవగాహన కేంద్రం గురించి సమాచారం అందించండి, పాపా, గ్రామం, ఎవరి ద్వారా అవగాహనం కార్యక్రమం ఏర్పడినది తెలియజేయండి.

The Public Information Officer through Letter dated 06-09-2021 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **11-10-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The Public Information Officer through Letter dated 21-10-2021 informed to the appellant that the information furnished by the Colliery Manager KTK-6 Incline, BHP Area vide Letter dated 16-10-2021.

Stating that the appellant was not satisfied with the reply of the Public Information Officer and did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **23-02-2022 at 10.30 AM.**

The Case is heard on 23-02-2022. The appellant is absent. The PIO/Sri Azmeera Thukaram, Personnel Manager, O/o. SCCL, Bhupalpalli area, Jayashankar Bhupalpalli District is present and stated that the information sought by the appellant is seeking personal information and is invasive of the privacy of individuals. Hence vide letter Ref: BHP/KTK.6/2021/W-55/3979, dated. 16-10-2021 the appellant was informed the same through registered post.

Heard the PIO and perused the material papers available on record. The Commission observed that the information sought by the appellant is not specific and as per Section 8(1)(j) of RTI Act, the PIO has rejected to furnish the information stating that the information comes under personal information of the individuals.

The Commission did not accept the plea made by the PIO and thereby directs the PIO to furnish the information to the appellant following the guidelines of Section 8, 9, 10 & 11 of RTI Act, 2005 within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
