## **Order**

Sri MD. Khalid Pasha has filed second appeal dated **29-11-2021** which was received by this Commission on **02-12-2021** for not getting the information sought by him from the Public Information Officer/ O/o the DM&HO., Warangal Urban District and the First Appellate Authority/ O/o the DM&HO., Warangal Urban.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **12-04-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. **Furnish the Certified Copies of Application, along with Relevant documents, Submitted by the Hospital above said for Registration, Before the District Registering Authority.**
2. **Furnish the Price list of the services and Procedures offered by the above said Hospital and approved by District Registering Authority.**
3. **Furnish the Certified copies of Inspection reports, Regarding to the Inspection conducted by District Registering Authority at the time of issuing certificate of Registration, Renewal and subsequent periodical inspections.**
4. **Furnish the certified copies of certificates Issued by the fire department regarding fire safety measures taken by the above said Hospital.**
5. **Furnish the certified copies of the Building plan Approved by the local body, in which the above said hospital is located.**
6. **Furnish the dates of meetings of District Registration Authority for the last five years, held under rule 3(2) of T.P.A.P.M.C Establishments (Registration and Regulations) Rules, 2007.**
7. **Furnish the list of Medical records maintained by the above said hospital as per Rule 14 of T.P.A.P.M.C. Establishments (Registration and Regulations) Rules, 2007.**
8. **Furnish the details of action taken by the above said hospital in compliance of Rule 15 of T.P.A.P.M.C. Establishments (Registration and Regulations) Rules, 2007.**
9. **Furnish the details of action taken against the Doctor who has violated Rule 10(c) of T.P.A.P.M.C. Establishments (Registration and Regulations) Rules, 2007**
10. **Furnish the certified copies of latest price list submitted by the above said hospital as per Rule 9(a) Of T.P.A.P.M.C. Establishments (Registration & Regulations ) Rules, 2007 and Furnish the details of action taken against the hospital who has violated Rule 9(a)**

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **19-11-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-03-2022 at 10.30 AM.**

The Case is heard on 22-03-2022. The appellant is absent. The PIO/ Sri B.Yadagiri, Administrative Officer, O/o the DM & HO, Warangal Urban District is present and stated that vide letter Rc.No.Estt/RTI/66/2021, dated.22-12-2021 the information sought by the appellant was furnished through registered post. The PIO further filed a copy of the information along with the copy of the postal receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
