Order

Sri Syed Wajeehuddin has filed second appeal dated **06-12-2021** which was received by this Commission on **07-12-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Telangana State Archives & Research Institute, Tarnaka, Hyderabad and the First Appellate Authority/ O/o the Telangana State Archives & Research Institute, Tarnaka, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **04-10-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

I, Syed Wajeehuddin submit that one Smt. Syeda Tasneem Afifa filed the suit against me i.e. O.S.No.2530 of 2020 before IX Junior Civil Judge, City Civil Court, Hyderabad.

I submit that in the suit O.S.No. 2538 of 2020 before IX Junior Civil Judge, City Civil Court, Hyderabad Smt. Syeda Tasneem Afifa filed forged Hiba Name by witness signature (1) Ghousia Begum (2) Syed Aleemuddin Hussaini.

I submit that Ghousia Begum was taken family pension after the death of her husband late Syed Qutub Uddin Hussaini from your department. Ghousia Begum death on 19th October, 2018, before death, she was taken the family pension.

Further I, submit that Syed Aleemuddin Hussaini is also present working in your office.

That apart to proof the forged signature of Ghousia Begum and Syed Aleemuddin Hussaini; I want attested certify copy of Ghousia Begum signature and Syed Aleemuddin Hussaini signature of extract copy of the signatures under RTI Act to submit before the court in O.S.No.2538 of 2020 before IX Junior Civil Judge, City Civil Court, Hyderabad.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **10-11-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **05-01-2022 at 10.30 AM.**

The Case was heard on 05-01-2022. The appellant is present and stated that the PIO has not furnished the sought information. The APIO/ Sri G.Srikanth, Assistant Director, O/o. the Telangana State Achieves & Research Institute, Tarnaka, Hyderabad is present and stated that the appellant is seeking information relating to a third party and vide letter No.E2/1911-A/2021, dated. 24-11-2021 the same was informed to the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that the information sought by the appellant is a third party information and the PIO has rejected to furnish the same under Section 8(1)(j) of the RTI Act,2005.

In view of the above, the appeal is closed.
