Order

Sri V. Aravind has filed second appeal dated **15-12-2021** which was received by this Commission on **17-12-2021** for not getting the information sought by him from the Public Information Officer/ the Deputy Tahsildar, Doma Mandal, Vikarabad Division, Vikarabad District and the First Appellate Authority/ the Revenue Divisional Officer, Vikarabad, Vikarabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **14-09-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

The Public Information Officer through Lr.No. A/985/2021 dated 21-10-2021 informed to the appellant that the file sought by him is not available in the record section and if found the same may be furnished to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **22-10-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Notice No. A1/2090/2021 dated 01-11-2021 requested the appellant and the Public Information Officer to attend for hearing on 15-11-2021 at 12.00 PM along with necessary documents without fail.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **09-02-2022 at 10.30 AM.**

The Case is heard on 09-02-2022. The appellant is present and through affidavit stated that he has received full information. The PIO/Sri T.Rajender Reddy, Nayab Tahsildar, Doma Mandal, Vikarabad District is present and stated that vide letter No.A/985/2021, dated.07-02-2022 the information sought by the appellant was furnished personally in their office. The PIO further submitted a copy of the information along with the personal acknowledgement of the appellant. Sri G.Amarendra Krishna, DAO, O/o. the Revenue Divisional Officer, Vikarabad Division is present and stated that the PIO/ Nayab Tahsildar, Doma Mandal, Vikarabad District was directed to furnish the information directly to the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant with an abnormal delay. The Commission took a serious view against Public Information Officer for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
