## **Order**

Sri Mohd. Imtiyaz has filed complaints dated **15-12-2021** which was received by this Commission on **22-12-2021** for not getting the information sought by him from the Public Information Officer/ O/o the District Planning Officer, District Collectorate, Vikarabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed applications dated **04-09-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

**Background matter of this application is: Shri.Koppula Mahesh Reddy is the MLA of Pargi Assembly Constituency from 2018 to till date.**

This application is registered to provide the following information as per the provisions of the RTI Act with also observing the notes and CIC decision cited/mentioned in this Application.

1. Let be supplied me with the certified copies of all the letters of recommendation of works received from Shri. Koppula Mahesh Reddy, Honorable MLA, to undertake those works under MLA LADS, during his current tenure as MLA and allotted your District from 2018 to till date.
2. Let be provided me all the recommendations in the following format in a tabular column:

3. Let be provided me the information relating to all works recommended by the MLA during his current tenure as MLA and allotted to your District, in the following format, as this format is prescribed/utilized by Ministry of Statistics and Program Implementation in 'Works Monitoring System'.

4. Let me know the list of contractors of all the above works.
5. Let be supplied me the certified copy of the contractors' work report.
6. Date of Receipt of Proposal from MLA.
7. Whether the work is Sanction.

9. Executing Agency
10. Date of Completion

Stating that the complainant did not get any response from the Public Information Officer, he preferred two complaints before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **09-02-2022 at 10.30 AM.**

The Cases were heard on 09-02-2022. Sri Mohammed Bin Amer, representative of the complainant is present and stated that he has received the information on the day of hearing. The PIO/ Sri C.Niranjan Rao, City Planning Officer, Vikarabad District is present and through affidavit stated that vide letter Lr.No.737/VKB/RTI/2021, Dated.21-09-2021 the available information was furnished to the complainant through ordinary post. The PIO further submitted a copy of the letter along with personal endorsement of the complainant.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has failed to provide any proof of furnishing the information to the complainant and furnished the same on the day of hearing. Hence the Commission warns the PIO not to repeat the same in the future.

Since the information is furnished, the complaints are closed.
