Order

Sri K. Kalappa has filed second appeal dated **27-12-2021** which was received by this Commission on **27-12-2021** for not getting the information sought by him from the Public Information Officer/ the District Revenue Officer, Vikarabad District and the First Appellate Authority/ the Joint Collector, Vikarabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **03-08-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- ① క్రమ సంఖ్య TS 340611, క్రమం I.P.C కి C.R.P.C మరియు సమాచార హక్కు చట్టానికి సంబంధించిన అంశాల ప్రయోజనం కొరకు అనుమతి కోరడం అది 04/09/2018 నాడు పరకండ్ల ఇచ్చినను ద్వారా సంబంధించిన "ఫైల్" పత్రాల ఇవ్వగలను. [Note file]
- ② వట్ల నర్సయ్య 5% చంద్రయ్య వారసుల సర్టిఫికేట్ 174' లో భాగం క్రమం డిలెట్ అయింది అని పూర్తి అదరలలో 29/06/2021 నా నుండి ఇచ్చినను ద్వారా పై వారసుల సర్టిఫికేట్ లోని అంశాల ఇవ్వగల పత్రాల ఇవ్వ - కోర్ కోర్ డిలెట్ కారణంగా ఇవ్వగల ను అంశాల పత్రాల ఇవ్వగల పత్రాల ఇవ్వగల.
- ③ క్రమ అక్షరాలతో సంబంధించిన R.T.I Act 2005 Sec 4(1)(B) ప్రకారం 17 రూపాల వివరం ఇవ్వగలను.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **07-09-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **09-02-2022 at 10.30 AM.**

The Case is heard on 09-02-2022. The appellant is absent. The PIO/ Smt. Haritha Devi, Administrative Officer, O/o the District Collectorate, Vikarabad District is present and submitted a letter Lr.No.A3/429/2022, dated. 08-02-2022 stating that the appellant is seeking 3 points information and the information for point No.1 & 2 is not specific and the information for point No.3 is updated in the Official website.

Heard the PIO and perused the material papers available on record. The Commission observed that though the information sought by the appellant is not specific the PIO ought to have replied the same to the appellant but failed to do so.

The Commission took a serious view against Public Information Officer for not furnishing a reply/information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Hence the Commission directs the PIO to furnish a specific reply to the appellant within one week through RPAD and to report compliance to the Commission.

The Commission also advises the appellant to file a separate 6(1) application before the concerned PIO and seek specific information.

With the above direction, the appeal is closed.
