Order

Sri K. Madhusudhan has filed complaint dated **22-11-2021** which was received by this Commission on **28-12-2021** for not getting the information sought by him from the Public Information Officer/ O/o the General Manager, SCCL, Srirampur Area, Mancherial District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **22-11-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

1. Please provide the following information regarding installation, purchase and provision of AC Units.

 2. Please furnish the list of approved points/location where AC's units are pending for installation as of now by competent authority.
 3. Please provide the copy of the log book/ record maintained with AC unit local number, location of the AC with other details since 2000 year.
 4. Please provide the copy of approval orders/notes for installation of AC unit for each location since 2000 year where AC units were installed and pending for installation.
 5. Please provide copy of purchase orders placed for supply of AC's since 2000 year and No. of AC units supplied against each purchase order since 2000 year in the following format.

PO Number & date	No. of AC units supplied	Date of supply.

 6. Please furnish the information regarding installation date, survey off date and mode by which the scrap AC's are surveyed off and disposed with documentary evidence pertaining to the AC units supplied since the year 2000.
 7. Please furnish the life span of an AC unit after which the unit shall be surveyed off.
 8. Please provide the circular relating to provision of AC's to the residences and offices allotted by company to Area General Manager / other designated General Managers / Addl. General Managers / Dy. General Managers.
 9. Please provide the information of AC units provided to the residence of Area General Manager, SRP with local AC Number and inform No. of AC Units for which he is eligible with copy of note/circular
 10. Provide the copy of the circular by which Area General Manager is eligible for any additional AC units than any other Designated General Managers.
 11. Also provide the facility to visit/verify physically the site of installation of AC units and connected records as per clause-2(j) of RTI Act-2005.
- Please provide all certified copies and allow the above information to use as evidence in legal/judicial structure of India.

The Public Information Officer through Ref. Dated 17-12-2021 furnished available information to the appellant through Letter dated 14-12-2021.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-02-2022 at 10.30 AM.**

The Case is heard on 15-02-2022. The appellant is absent. Sri M.Rajesh, Sr.Personnel Officer on behalf of the PIO/Sri P.Govinda Raju, DGM(Per), SCCL, Srirampur Area, Mancherial District is present and submitted that vide letter Ref.No:SRP/PER/RTI/25.000/598, dated.01-02-2022 the information sought by the appellant was rejected under section 8(1)(j) of RTI Act.

Heard the PIO and perused the material papers available on record.

The Commission did not accept the plea made by the PIO and directs the PIO to furnish the information to the appellant following the guidelines of Section 8, 9, 10 & 11 of RTI Act, 2005 within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
