Order

Ms. S. Aruna has filed second appeal dated **29-12-2021** which was received by this Commission on **30-12-2021** for not getting the information sought by him from the Public Information Officer/ the Revenue Divisional Officer, Tandur Division, Vikarabad District and the First Appellate Authority/ the District Revenue Officer, Vikarabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **28-07-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the appellant did not get any response from the Public Information Officer, she filed 1st appeal dated **06-09-2021** before the First Appellate Authority requesting him to furnish the information sought by her u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate

Authority, she preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing

on **09-02-2022 at 10.30 AM**.

The Case is heard on 09-02-2022. Sri S.Suban Reddy, husband of the

appellant is present and stated that the PIO has not furnished the information. Sri

P.Kiran Kumar, Naib Tahsildar on behalf of the PIO Sri Mahesh Goud, Divisional

Administrative Officer, Tandur Division, Vikarabad District is present and

submitted that vide letter No.B154/2022,dated.08-02-2022 the available

information was furnished to the appellant and also submitted a copy of the

information before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission observed that the PIO has not furnished the complete information

to the appellant.

Hence the Commission warns the PIO not to repeat the same in the future

and directs the PIO to furnish complete information to the appellant within two(2)

weeks through Registered Post with Acknowledgement Due and to report

compliance to the Commission. If the PIO fails to comply with the instructions

issued, action will be taken against the PIO as per Section 20 of RTI Act.

With the above direction, the appeal is closed.
