Order

Sri Vijay Gopal has filed complaint dated **07-02-2020** which was received by this Commission on **07-02-2020** for not getting the information sought by him from the Public Information Officer/ O/o the Commissioner of HM&FW Department, Koti, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **27-12-2019** before the Public Information Officer/ O/o the DM&HO., T.S. Secretariat, Hyderabad requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Request you to please provide the information for the below queries in the questions and answer against it so the same can be produced in the court of Law for Public Interest Litigation.

The Public Information Officer through Letter dated 31-12-2019 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ O/o the Commissioner of HM&FW Department, Koti, Hyderabad with a request to furnish the available information to the complainant under intimation to their office.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-03-2022 at 10.30 AM.**

The Case is heard on 15-03-2022. The complainant is absent. The PIO/ Smt.G.Vijaya, Assistant Director(FW), O/o the Commissioner of Health Medical & Family Welfare, Hyderabad is present and stated that vide letter Rc.No.20/Fw/RTI/2019, dated.03-04-2019 & 02-06-2019 the complainant was informed that the information sought by him does not fall under their purview and requested him to approach the PIO/O/o the Director of Public Health & FW, Hyderabad by forwarding the 6(1) application U/s 6(3) of RTI Act to the PIO/ O/o the Director of Public Health & FW, Hyderabad. The PIO further filed a copy of the letter.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO/ O/o the Director of Public Health & FW, Hyderabad to furnish the information to the complainant within one week from the date of receipt of this order through RPAD and to report compliance to the Commission. If the PIO fails to comply with the instructions issued, action will be initiated against the PIO as per Section 20 of RTI Act.

With the above direction, the complaint is closed.
