Order

Sri Ch. Jaya Prasad has filed complaint dated **04-01-2019** which was received by this Commission on **05-01-2019** for not getting the information sought by him from the Public Information Officer/ The Superintendent, O/o the Gandhi Hospital, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **05-10-2018** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

I 'Chittala Jaya Prasad' hereby to state that my wife 'Chittala Shanthi' alias 'Gilla Shanthi' was admitted into your hospital on 19/6/2017 with IP no 33271, MLC no 9820.

Kindly furnish the Discharge **Summary Report of said patient** .

Also, pls note & humbly say that I am her husband and not a third/private party to this case and your cooperation in this regard would help us much.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **20-04-2021 at 10.30 AM.**

The case was heard on 20-04-2021. The complainant was absent. The Public Information Officer was also absent. Hence, the case was **adjourned.**

In view of the above, notice is issued to both the parties to attend for hearing on **08-03-2022 at 10.30 AM.**

The case is heard on 08-03-2022. The complainant is present and stated that the PIO has not furnished the discharge summary report of his wife till date. The PIO/O/o. the Superintendent, Gandhi Hospital, Secunderabad is absent.

The Commission perused the material papers available on record and observed that the PIO has not furnished the information and was also absent for hearing even after the receipt of notice from the Commission. The Commission took a serious view against the PIO and directs to issue **Show Cause Notice** to the PIO for not furnishing the information to the complainant.

The Commission also directs the First Appellate Authority/Superintendent, Gandhi Hospital to submit his explanation in person within one week from the date of receipt of this order for not taking any action against the Public Information officer in implementing the RTI Act and also for his absence for hearing even after the receipt of the notice from the Commission.

The Commission also directs the PIO to furnish the information to the complainant within one week from the date of receipt of this order through RPAD and to report compliance to the Commission. The action on **Show Cause Notice** will be dealt separately.

With the above direction, the complaint is closed.
