Order

Sri GK. Sampath Kumar has filed second appeal dated **07-01-2020** which was received by this Commission on **07-01-2020** for not getting the information sought by him from the Public Information Officer/ The Addl. GM (IE) IED., O/o the SCCL., Kothagudem Area, Bhadradri – Kothagudem District and the First Appellate Authority/ The GM (HRD), SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **04-11-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- I am enclosing herewith postal order No. 46F: 127248 for an amount of Rs. 10/- as per Sec 6 (1) for collecting information under RTI Act, 2005.
- 1) Please arrange to supply approved note copy for declaring holiday on 27.02.2018 in Ramagundam & Bellampalli region as per CRP/PER/IR/H/240/264,Dt:26.2.2016
 - 2) Please arrange to supply approved note copy for arranging 400 buses on 27.02.2018 by SCCL as per CMD/PS/H/18, Dt:25.2.2018.
 - 3) Please arrange to supply approved note copy issuing modified Corporate medical board rules vide CRP/IRPM/C/081/1218,Dt:7.4.2015, CRP/MED/C/32/1551,Dt:21.4.2015& CRP/MED/C/32/697,Dt:30.4.2015.
 - 4) Please arrange to supply C&MD approved note copy issuing modified Corporate medical board rules Vide CRP/PER/IR/C/305,Dt:9.3.2018 & CRP/PER/IR/C/306,Dt:9.3.2018.
 - 5) Please arrange to supply approved note copy of competent authority for taking action against 13 executives whose charges were proved in misappropriation of funds in Medipalli OCP Ramagundam
 - 6) Please arrange to supply approved note copy of competent authority for taking action against 73 employees who produced fake stunt medical reports in Corporate Medical Board in the year 2016-17.
 - 7) Please arrange to furnish the number of executives issued charge sheets in Sand scam at STPP in the year 2017.
 - 8) Please arrange to furnish the number of executives issued charge sheets in misappropriation of HSD at Srirampur Area in the year 2019.
 - 9) Please arrange to supply Approved note copy of VRS Circular issued in the year 2016 Vide :CRP/PER/IVR/V/623/1935,Dt:20.12.2016.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **05-12-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No.CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of “Singareni Formation Day Celebrations to be celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

The Public Information Officer through Letter dated 14-12-2021 requested the Public Information Officer/ GM(Per) RC, IR & PM to furnish the information (for Point No. 1,2,3,4,6 & 9) so as to enable to forward the same to the applicant and to the TSIC., Hyderabad.

In view of the above, informed to both the parties over phone to attend for hearing on **11-01-2022 at 10.30 AM.**

The Case is heard on 11-01-2022. The appellant is absent. The PIO/Sri Dhanpal Srinivas, DGM(P), SCCL, Kothagudem Area is present and submitted that vide letter Ref.No.CRP/PER/C/37/4324, datd.30-12-2021 the appellant was informed that the information sought by him pertains to extension of deputation of the Chairman & MD of SCCL and since the matter is Sub-Judice in the Hon'ble High Court of Telangana the same was informed to the appellant and for remaining information vide letter Ref.No.CRP/PER/C/37/RTI/4307, dated.27-12-2021 the appellant was informed that the information sought by him qualifies to the personal information of third party and the same was rejected under Section 8(1)(j) of RTI Act, 2005. The PIO further stated that vide letter Ref.No.CRP/PER/IR/R/251/1623, dated.18-12-2021 the available information was furnished to the appellant through registered post.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has rejected to furnished the information to the appellant following Section 8(1)(j) of RTI Act, 2005.

In view of the above, the appeal is closed.
