Order

Sri GK. Sampath Kumar has filed second appeal dated **07-01-2020** which was received by this Commission on **07-01-2020** for not getting the information sought by him from the Public Information Officer/ The Addl. GM (IE) IED., O/o the SCCL., Kothagudem Area, Bhadradi – Kothagudem District and the First Appellate Authority/ The GM (HRD), SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **31-10-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) (a) Please arrange to furnish the total Number of employees applied for Corporate Medical Board after issue of the circular in March' **CRP/PER/IR/C/081/305, Dt: 09.03.2018 & CRP/PER/IR/C/081/306, Dt:9.3.2018.**
- (b) Please arrange to furnish the total Number of employees applications lying for want of Corporate Medical Board from **April' 2017 to March'2018.**
- 2) (a) Please furnish the total Number of Corporate Medical Boards held after issue of **CRP/PER/IR/C/081/305, Dt: 09.03.2018 & CRP/PER/IR/C/081/306, Dt:9.3.2018.** that is from **April'2018 to Oct'2019.**
- (b) Please furnish month wise Number of employees were made "Medical Invalidity" from **April'2018 to Oct'2019.**
- (c) Please furnish the total number of employees referred by Corporate Medical Board to NIMS from **April'2018 to Oct'2019.**
- (d) Please furnish the total number of employees paid Half pay salary beyond six months from **April' 2017 to March'2018** and also supply a copy of circular issued on the subject.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **02-12-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No.CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of “Singareni Formation Day Celebrations to be celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

In view of the above, informed to both the parties over phone to attend for hearing on **11-01-2022 at 10.30 AM.**

The Case is heard on 11-01-2022. The appellant is absent. The PIO/Sri Dhanpal Srinivas, DGM(P), SCCL, Kothagudem Area is present and submitted that except for personal information, vide letter Ref.No.CRP/RTI-PIO/2933/TSIC/1204, dated.29-12-2021 and letter REF.CRP/MEDKGM/RTI/2019 the information sought by the appellant was furnished through registered post. The PIO further submitted a copy of the information along with the copy of the postal receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant following Section 8(1)(j) of RTI Act, 2005.

Since the information is furnished, the appeal is closed.
